The petitioner has prayed for an order restraining the respondents from shifting the Chowk Thana, Telephone Exchange, Temple, Ittim Khana and others building intended to be shifted for celebrating 350th Birth Anniversary of Sri Guru Govind Singhji.

The petitioner relies upon CWJC No.3853 of 2015 (Patna Zila Sudhar Samitee Vs. The State of Bihar & Ors.) wherein,



there was an *ad interim* order of not shifting *Narayani Kanya Girls* High School, Patna City. The said writ application has since been decided on 30th March, 2016 wherein, in the counter affidavit, the stand was that there was no decision to shift the school.

Learned counsel for the State states that there is no decision to shift the buildings in question in the present writ application as well.

In view of the said facts, no further orders are called for in the present writ application. Disposed of.
