In the matter of conduct of selection process by the Bihar Combined Competitive Examination Board for appointment on the post of Assistant Manager and Assistant Accountant, in the competitive examination conducted with regard to objections in the questions and the model answers, the



learned Writ Court has examined the issue in detail, gone through the expert opinion and has refused to interfere into the matter finding the Board to have taken action after referring the matter to the experts and following the guidelines with regard to the preparation of the model answers and valuation of the O.M.R. Sheets.

The learned Writ Court having dealt with the issue in detail, we see no error in the same warranting reconsideration. The Letters Patent Appeal stands dismissed.
