6      11-09-2017              In the present writ application, the following relief has  
  
been sought for on behalf of the petitioner.

“1. This writ application is being filed for direction to the respondents to give the opportunity for appointment of the petitioner on the post of Panchayat Teahcer for which she is entitled. Further direction to the respondents to appoint the petitioner on the post of Panchayat teacher which is vacant after termination of Smt. Kumari Indrakala Sinha Prakhand Teacher (the then



Panchayat Teacher) by the letter issued under the signature of Director, Primary Education, Bihar, Patna vide his Patrank 622 dated 12.09.2012 and Patrank 6363 dated 29.09.2012 issued under the signature of District Education Officer, Vaishali.”

The petitioner is directed to file an appropriate application for redressal of her grievance before the District Appellate Authority, Vaishali within a period of thirty days from the date of this order and the same shall be disposed of within the statutory period.

With the aforesaid observation and direction, the present writ application stands disposed of.
