On perusal of Annexure-A of the show cause dated 12.03.2014, it is seen that in pursuance to the order passed on 29.03.2012 in Civil Writ Jurisdiction Case No. 1718 of 2010, the matter was placed before the Pricing Committee and the Pricing Committee has taken certain decision in the matter as is evident from Annexure-A.



That being so, now no case is made out to make any indulgence into the matter. In case the petitioner has any grievance with regard to the manner in which the Pricing Committee has dealt with the issue in question, it gives fresh cause of action to the petitioner to challenge the same, in accordance with law.
