5 30-08-2017 Learned counsel for the petitioner seeks permission to withdraw the present application with liberty to prefer an appeal before the State Appellate Authority against the order dated 31.10.2011, as contained in Memo No.1309 dated 04.11.2011, passed by the District Teachers Employment Appellate Authority,
