The writ application was disposed of by the learned Single Bench on 10th of December, 2009 granting liberty to the petitioner to bring on record all materials against Sri Lakshmi Kant Jha, the Assistant Teacher by way of a representation before the Regional Deputy Director of Education, Darbhanga Division, Darbhanga who would enquire into the matter expeditiously and take action as appropriate in the facts and circumstances of the case. In pursuance of such direction, an inquiry has been completed by the



Regional Deputy Director of Education, Darbhanga to the effect that allegations against Lakshmi Kant Jha are not proved and that request of the petitioner for transfer of Lakshmi Kant Jha is also not acceptable.

In view of the order passed, the order passed by this Court stands complied with.

The Contempt Petition stands disposed of accordingly.
