Heard Mr. Ashwini Kumar Rai, learned Counsel appearing on behalf of the petitioner, Mr. Shivendra Kumar Sinha, learned Counsel appearing on behalf of Respondent No.7 and learned AC to AAG-4, appearing on behalf of Respondent Nos. 1 to 6.

The present writ application has been filed for a direction to the respondent authorities to restrain the private respondent No.7 from encroaching the land, pertaining to C.S. Khata No. 200, Plot No.680, measuring an area 2 decimals, situated at Mauza - Belaon,



District –Buxar, which is being used as Aam Rasta and the same has been recorded in the C.S. record as ‘Anabad Sarv Sadharan.

It is submitted by learned Counsel appearing on behalf of the respondent-State that after filing of the writ application, the encroachment has been removed which gets reflected from Annexure-A series to the counter affidavit, filed on behalf of Respondents.
