9      08-08-2017                      Learned counsel for the petitioners seeks permission to withdraw the present application with a liberty to prefer an appeal before the State Appellate Authority, challenging the order dated 11.09.2012, passed in Case No. 04 of 2009 by the Member, District Teachers Employment Appellate Authority, Araria, which is under challenge, in this writ application.

Permission is accorded.

The petitioners shall file an appeal within a period of thirty days from the date of the order and the same shall be disposed of within the statutory period, in accordance with law.



It has further been pointed out by learned counsel for the petitioners that the petitioners were granted interim relief by this court vide order dated 18.03.2013. The petitioners will be at liberty to file a separate application for grant of any interim relief, if so advised, within a period of ten days from the date of filing of the appeal.
