Heard learned counsel for the parties.

The petitioner seeks regular bail in connection with
Barachatti P.S. Case No. 187 of 2016 for the offences
punishable under Sections 387, 323, 307/34 of the Indian Penal
Code and Section 27 of the Arms Act as also Section 17 of the
C.L.A Act.

Informant is munshi of Ramiya construction company
which is engaged in construction of Shobh-Dhangain road and
on 01.06.2016, petitioner and other named accused in FIR
arrived at site of work and assaulted and threatened employees
that they will not be allowed to construct the road unless levy is
paid by Bindi Yadav.

It has been submitted on behalf of the petitioner that the
petitioner has been roped in this case due to enmity and he has



no concern with any extremist organization or P.L.F.I. Learned counsel for the petitioner has produced gist of orders by which petitioner has been granted bail in different cases of similar nature lodged against him, by a different benches of this Court vide order dated 05.07.2017 in Criminal Miscellaneous No. 29170 of 2017, 20.03.2017 in Criminal Miscellaneous No.7421 of 2017, 14.07.2017 in Criminal Miscellaneous No.29043 of 2017, 11.04.2017 in Criminal Miscellaneous No. 12617 of 2017, 19.04.2017 in Criminal Miscellaneous No. 14878 of 2017, 28.04.2017 in Criminal Miscellaneous No. 12504 of 2017, 20.04.2017 in Criminal Miscellaneous No. 14947 of 2017 and 13.06.2017 in Criminal Miscellaneous No. 23825 of 2017.

Considering the aforementioned facts and circumstances of the case, let the above named petitioner be released on bail on furnishing bail bond of Rs. 10,000/- with two sureties of the like amount each to the satisfaction of **A.C.J.M., Sherghati, Gaya** in connection with **Barachatti P.S. Case No. 187 of 2016.**
