Date : 22-11-2017

Seeking exception to an order dated 1.9.2015 passed by the learned Writ Court in C.W.J.C. No.8200 of 2015, this appeal has been filed under Clause 10 of the Letters Patent.

Seeking shifting of a date for promotion granted to the petitioner more than 17 years back, the writ petition in question



was filed in the year 2015, i.e. 17 years after his retirement in the year 1999. Finding that now after such a long period of time, claim of the petitioner for shifting the date of promotion cannot be permitted, the writ petition has been dismissed.

In doing so, we are of the considered view, the learned Writ Court has not committed any error warranting re-consideration.

The appeal is, therefore, dismissed.
