Heard.

1. Learned counsel for the respective respondents, upon instructions, submits and informs the Court that the orders of transfers of Assistant Teachers, who were transferred from one Janpad Panchayat to the other Janpad Panchayat, without their consent, have now been cancelled which includes the name of the petitioners.
2. Before this Court, this statement is not disputed by learned counsel for the respective petitioners.
3. In view of the above, these petitions are rendered infructuous and disposed off as such.
4. This order shall not come in the way of transfers of the Assistant Teachers within the same Janpad Panchayats. In case, there are vacancies of Assistant Teachers in the respective schools in different Janpad Panchayats, it could be filled up either by transferring Assistant Teacher from one Janpad Panchayat to the other Janpad Panchayat, after taking their consent or by filling up the post by way of direct recruitment according to the applicable Rules.
