1. Heard.
2. Learned counsel for the parties would not dispute that the matter in issue pertaining to payment of salary during the period the petitioners remained on transfer, which was subsequently found to be illegal, is no longer *res integra*, as the same has been settled by this Court in the matter of **Ku. Girija Patel Vs. State of Chhattisgarh and others** (WPS No.2791 of 2017, decided on 03.07.2017).
3. In view of the above, this petition is also disposed of in terms of the order passed in **Girija Patel (supra)**.
4. Consequently, the petitioners are held entitled to the wages with effect from the date of transfer till the date they join their duties.
5. Let necessary steps be taken within a period of 60 days from today.
6. The writ petition stands allowed in the above stated terms.
