- (1) Learned counsel appearing for the petitioner would submit that the petitioner's substantive appeal is pending before the Chhattisgarh State Co-operative Tribunal (henceforth "Tribunal") and application for interim relief (*ex parte*) has been rejected pending notice to the other side.
