We have heard the learned counsel for the Appellant-Revenue on all the issues sought to be raised. We have perused the impugned order of the Income Tax Appellate Tribunal, Raipur Bench, Raipur and are of the view that the questions raised are fundamentally those which revolve on issues of facts. The adjudication by the Tribunal or by the authorities of the department do not give rise to any substantial question of law for consideration in this income tax appeal in favour of the Revenue under Section 260A of the Income Tax Act, 1961.
