1. Petitioners are seeking quashment of the proposed amendment in the Chhattisgarh Industrial Training (Gazetted) Service Recruitment Rules, 2005.
2. Till a particular amendment is made part of the statute book, the same cannot be quashed as it has not yet taken birth or shape of a legislation. There is no concept of an anticipatory writ to challenge a proposed legislative action. As and when the Government amends the Rule, the petitioners may file an appropriate writ petition in accordance with the Rules of the Court.
3. Accordingly, the writ petition is dismissed as premature.
