2 These petitions, as such, can be disposed of with a directions to Respondent No.6 to take decision, in accordance with law, on the representation/s tendered by petitioners and the representations, those would be tendered by the petitioners within eight weeks from today, as expeditiously as possible, preferably within a period of four months from today; and it is accordingly directed. The Deputy Commissioner (Sales Tax) shall consider the contentions raised in the representation/s in accordance with law. In the event of taking of any coercive action by respondents, liberty to the petitioners to avail of remedies available in law.

3 With the directions as above, these writ petitions stand disposed of.
