PER COURT :-

1. Learned Counsel for the applicants submits that in earlier matter arising out of the same acquisition proceedings this Court, vide order passed on 21.11.2016, in Civil Application No.13850 of 2016 has permitted the applicants therein to withdraw 70 per cent of the deposited amount on submitting an undertaking. Learned Counsel appearing for the acquiring body does not dispute correctness of the submission so made. Copy of the earlier order is also placed on record.
