ORAL ORDER :

Where there is a spelling mistake or otherwise, so long as the claimant is claiming to be of “महादेव कोळी” Scheduled Caste, each of the claims to be scrutinized and verified by the Scrutiny Committee/s on its merits and in accordance with law by following our order and direction.

3. We direct the Competent Authority to correct the spelling and issue corrected certificate/s, as expeditiously as possible and within ten (10) days from the date of receipt of copy of this order.

4. Writ Petitions disposed of.
