- 1) Heard the learned Counsel for the applicant/s and learned Counsel for respondent, i.e. the original appellant.
- 2) Having regard to the grounds of objections raised in exception to the impugned Awards and the averments in the applications for withdrawal of the amount, I deem it appropriate to pass the following order,

ORDER

- i) The applicants are permitted to withdraw 75% of the deposited amount on submitting an undertaking that in the event any adverse order is passed against them, they will re-
