under appeals is hereby stayed on the condition that the Applicant shall
deposit the entire amount under the award with accrued interest thereon,
in this Court within a period of 12 (twelve) weeks from today, failing
which the order granting stay shall stand vacated automatically without
further reference to the Court. The Civil Applications for stay are
accordingly, disposed of.
