ORDER:

1. This is an application for condonation of delay. Perused the contents of the application. It appears that the applicant was prevented from certain causes such as financial constrain. Therefore, he/she was

unable to prefer the cross-objection within prescribed period of limitation.

2. Learned counsels appearing for the respondents have opposed the application, as the delay has not been explained satisfactorily.

3. In view of the submissions made by the respective counsels and in view of the observations of Supreme Court in the case of ***Ramanlal Deochand Shah v/s. State of Maharashtra, and another, reported in AIR 2013 SC 3452***, the application for condonation of delay is allowed. Delay caused in filing cross objection is hereby condoned. The applicant shall not be entitled for the amount of interest, other statutory benefits for the period for which the delay is sought to be condoned.

4. In view of the above, the delay caused in filing the cross-objection is hereby condoned. Civil applications are accordingly disposed of.

5. The matters be referred to the Lok-Adalat scheduled to be held on 09.09.2017.
