**ORDER:**

1. Heard learned counsel for the respective parties.
2. This are the applications for withdrawal of the amount of compensation. Learned counsel for both the sides submits that the first appeals presented by the

Acquiring Body have been withdrawn and disposed of in view of the Government Resolution dated 13.10.2011 and its corrigendum dated 12.02.2012.

3. Since the first appeals are disposed of, then there would be no hurdle to pay the amount of compensation deposited by the Acquiring Body in this Court at the time of presentation of the Appeals. The learned AGP has no objection to pay the amount of compensation to the respective claimants. Hence, the respective claimants/applicants are permitted to withdraw the amount of compensation deposited in this court in the respective appeals alongwith interest accrued thereon.
