1. We have by a separate judgment made Rule absolute and quashed the impugned notification dated 10th August 2017. We had earlier directed on 21st August 2017 that the files from the NGT Western Zone Bench should not be transferred or moved to NGT's principal seat in New Delhi pending our final decision.
