All these applications are for extension of time and with a prayer that the notice of demolition may not be implemented until the applications for regularization filed by the petitioners are processed/decided, in accordance with law.

2. The learned counsel for the respondent has opposed the said prayer stating that sufficient time is already granted.

3. By a common judgment and order dated 29/8/2016 in Writ petitions nos. 964/2015 and others, this Court had directed that the impugned notice of demolition shall not be implemented till 31/12/2016, in view of the then prevailing monsoon season and ensuing festivities.

4. A perusal of the judgment would clearly show that the implementation of the notice of demolition was not made dependent on the outcome of the application for regularization. Thus it is not possible to grant prayer clause (a) in the application.

5. The learned counsel for the petitioners states that in view of the ensuing school examinations of the children of the petitioners the time may be extended till 31/3/2017 as a last chance.

6. Considering the overall circumstances and the limited prayer made, and in view of the ensuing examinations, it is directed that the impugned demolition notice shall not be implemented till 31/3/2017.

7. It is made clear that no further extension shall be granted in the matter.
8. The Civil applications are disposed of in the aforesaid terms.
