. Civil Application No.468 of 2017 is for bringing on record the legal heirs of the deceased Appellant No.1. There is a delay in taking out the civil application. The delay is, however, explained in the civil application. For the reasons stated in the civil application, the delay is condoned. Civil Application is allowed in terms of prayer clauses (b) and (c). The

2 Civil Application No.467 of 2017 is for stay of the execution of the impugned judgment and decree. The impugned judgment and decree directs the partition and separate possession of the property to the Respondents.
