This Petition under Article 226 of the Constitution of India, challenges an order dated 16th March, 2016 passed by the Principal Commissioner of Income Tax-13, under Section 127 (2) of the Income Tax Act, 1961 (the Act). By the impugned order, the Petitioner's case (pending assessment proceedings) were transferred from Deputy Commissioner of Income Tax, Bombay to Assistant Commissioner, Central Circle, Aurangabad.

2 Mr. Suresh Kumar, learned Counsel appearing for the Revenue, on instructions, states that the impugned order dated 16th March, 2016 as well as the show cause notice dated 15th January, 2016 is being withdrawn. However, the learned Counsel for the Revenue seeks

liberty to issue a fresh show cause notice and pass a fresh order under Section 127 of the Act, if so advised. Liberty as prayed for, granted.

3 In view of the above statement made by Mr. Suresh Kumar on behalf of the Revenue, Mr. Bhutada, learned Counsel for the Petitioners seek to withdraw the Petition.

4 **Petition disposed of as withdrawn**, in above terms. No order as to costs.
