Heard the learned Counsel for the Applicant/
Petitioner. Learned Counsel invited my attention to the
communication dated 15/01/2015 and submitted that on

receiving the said information, the details were collected. Learned Counsel submits that the copy of the death certificate of Respondent No.2, who expired during the pendency of the Petitions is placed on record along with the application.
