1. These Civil Applications are moved by the Applicants for amendment in the Cross Objections in First Appeal Nos.413 of 1993, 414 of 1993, 416 of 1993, 417 of 1993, 418 of 1993 and 420 of 1993 in terms of Schedule of Amendment to the respective Civil Applications.
