4. Today, the petitioners as well as the 2nd respondent/defacto complainant are personally present before this Court and also have been identified. An affidavit of the 2nd respondent/defacto complainant dated 28.11.2017 is also filed to the effect that she has no objection to quash the F.I.R in Crime No. 742 of 2016 pending on the file of the first respondent.

5. Recording the same, the F.I.R in Crime No. 742 of 2016 pending on the file of the first respondent is quashed. The Criminal Original Petition is allowed. Consequently, the connected Miscellaneous Petition is also closed.

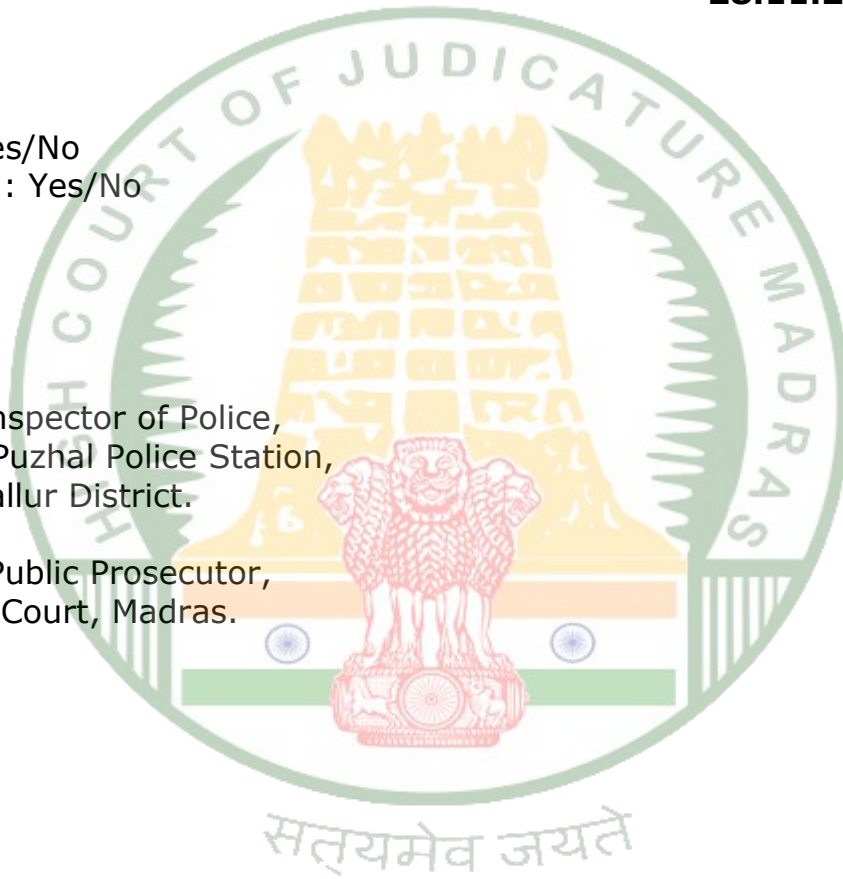
6. The affidavit filed by the 2nd respondent/defacto complainant dated 28.11.2017 shall form part of the order.
