JUDGMENT

[Judgment of the Court was delivered by M.SATHYANARAYANAN, J.]

It is represented by the learned Government Advocate [Crl.Side] that the appellant/sole accused, who has been convicted for the commission of the offence under Section 302 of IPC and imposed with the sentence of Rigorous Imprisonment for life and to pay a fine amount of Rs.5,000/-, in default, to undergo six months simple imprisonment, vide impugned Judgment dated 08.02.2016 in S.C.No.342 of 2012 on the file of the I-Additional District and Sessions Court, Coimbatore, had died in prison. The Special Sub-Inspector of Police, Sulur Police Station, has also filed a Memo dated 13.10.2017 to that effect, which is taken on file and recorded.

2. In the light of the same, the appeal is dismissed as abated.
