The suit filed by the appellants has been dismissed by the trial Court, after appreciation of pleadings and evidence. This petition has been taken out seeking an order of interim injunction restraining respondents 1 and 2 or their men and agents or any other claiming on their behalf from in any way encumbering or alienating the property.

2. The prayer sought for, as such, cannot be granted by this Court, at this stage. In any event, to safeguard the interests of both parties, it is ordered that any alienation would be subject to the result of the appeal suit. The C.M.P. is disposed of accordingly.

3. Post the Appeal Suit during March 2018.
