Order : These petitions coming on for orders upon perusing the petitions and the respective affidavits filed in support thereof and upon hearing the arguments of M/S.VENKATESH MOHANRAJ, Advocate for the petitioner in all the petitions, the court made the following order:-

According to the petitioner, the conditional order was made on 03.10.2017 and was made ready on 01.11.2017. Therefore, the petitioner could not comply with the conditional order passed by this Court. Hence, the petitioner has filed the present applications praying to modify the conditional order dated 03.10.2017 and to extend the time for compliance of the order of this Court.

In view of the reasons stated in the affidavit, this Court is inclined to grant further one week's time to comply with the conditional order dated 03.10.2017 from the date of receipt of a copy of this Order, failing which the interim order dated 03.10.2017 already granted by the Court stands automatically vacated.
