COMMON JUDGMENT

For the sake of convenience, the appellant and the respondents will be referred to as the complainant and the accused respectively.

2.The complainant has initiated prosecution in STC.Nos.176, 179, 175 and 177 of 2012 against the accused for the offence

under Section 138 of the Negotiable Instruments Act, in which, the learned Fast Track Court (Magisterial Level-I), Erode District, had acquitted the accused on 25.06.2013. Hence, the complainant has filed the present appeals against the order of acquittal before this Court.

3. Heard the learned counsel appearing for the complainant and the learned counsel appearing for the respondent Nos.1 and 2.

4. In view of the Judgment of the Full Bench of this Court in S. Ganapathy Vs. N.
