2. When the matter was listed on 17.04.2017, the learned Standing Counsel for the respondents took notice and sought time to get instructions.

3. Today, when the matter is taken up for hearing, Mr.Nedunchezhiyan, learned Standing Counsel appearing for the respondents 4 and 5, based on instructions, submitted that the subject matter TASMACH shop bearing No.914 is already closed and there is no proposal to re-locate the said shop at any other place.
