Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus directing the respondent authority to give police protection and permission to conduct cultural programme in Karungalpalayam, Kalingarayan Vaikkal Road, Vetrinagar Arulmigu Sree Sakthi Mariamman Temple festival, Erode Taluk & District on 29.03.2017 by considering the petitioner's representation dated 18.03.2017.

ORDER

This writ petition has been filed for issuance of a Writ of Mandamus to direct the respondent police to give police protection and permission to conduct the cultural programme at Karungalpalayam, Kalingarayan Vaikkal Road, Erode Taluk & District on 29.03.2017 in the event of Vetrinagar Arulmigu Sree Sakthi Mariamman Temple festival, by considering the petitioner's representation dated 18.03.2017.

2.It is the grievance of the petitioner that he has submitted a representation dated 18.03.2017 to the respondent, seeking permission to conduct Cultural Programme at Karungalpalayam, Kalingarayan Vaikkal Road, Erode Taluk & District on 29.03.2017 in the event of Vetrinagar Arulmigu Sree Sakthi Mariamman Temple festival. However, the respondent denied the permission to conduct the programme. Hence, this petition.

3.Though the petitioner sought for permission to conduct "cultural programme", learned counsel for the petitioner restricted the same to the extent of conducting Orchestra, for which, the learned Government Advocate appearing for the respondent has raised no serious objection.

4.In view of the submission so made by the learned counsel for the petitioner, the respondent is directed to consider the representation of the petitioner dated 18.03.2017 and grant permission to the petitioner to conduct Orchestra at Karungalpalayam, Kalingarayan Vaikkal Road, Erode Taluk & District on 29.03.2017 in the event of Vetrinagar Arulmigu Sree Sakthi Mariamman Temple festival, subject to usual conditions. It is made clear that this Court has not granted any direction to conduct "Adal Padal Nigazhchi / dance programme" in the name of "cultural programme".

5. The writ petition is disposed of accordingly.
