Till such time the decision is taken, status quo would be maintained as to the storage godown facility for agricultural produce and in the eventuality of an adverse order, for a period of fifteen days thereafter to enable the petitioner to avail of the legal remedy.

2. The writ petition, accordingly, stands disposed of. No costs.

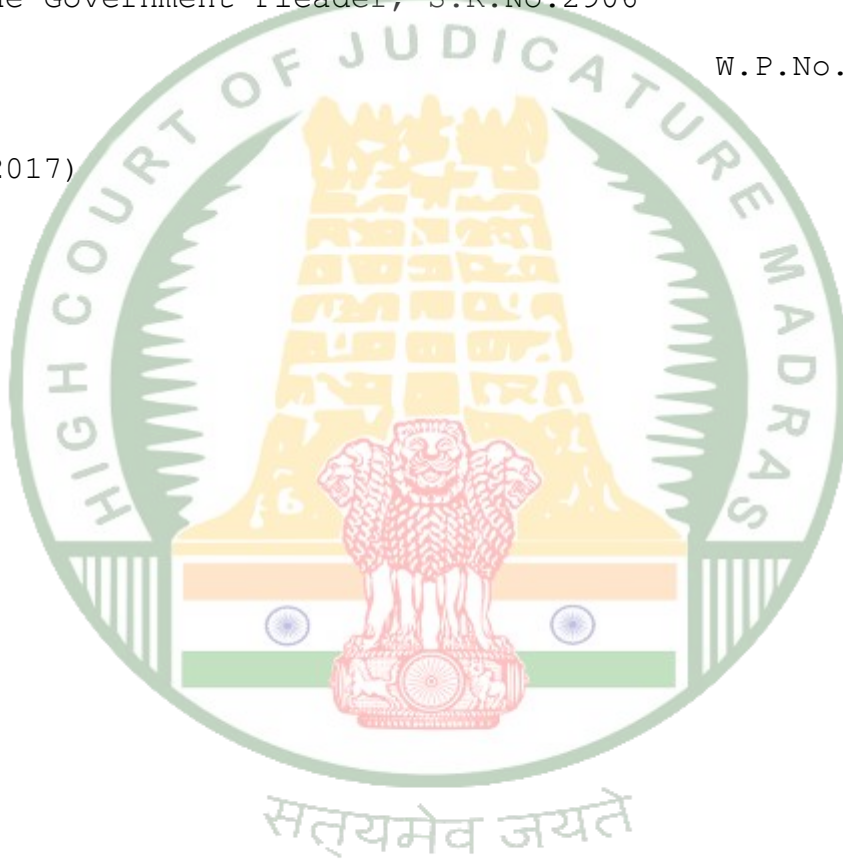
