Prayer in WP.No.13429/17:Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorari calling for the records relating (1) proceeding of the 2nd respondent in Na.Ka.No.28557/D5/2016 dated 12.05.2017 so far as petitioner alone is concern in respect of including petitioner in list of surplus teaching staff in the department of Tamil and (2) University order No.662/2017(c) dated 15.05.2017 issued by the 3rd respondent and quash the same consequently issue direction to respondents to identify the surplus Assistant professors based on the sanctioned strength of the University in Department of Tamil considering workload prevailing in department of Tamil Studies and Research by obtaining the report from the Academic Council faculty and Board of Studies .

JUDGMENT

(Judgment of the Court was delivered by

This writ appeal has been filed against the interim order passed by this Court in W.M.P.No.25363 of 2017 in W.P.No.13429 of 2017 dated 06.09.2017.

2.The matter relates to deputation of the appellant to the Government Arts College for Women, Kumbakonam.

3.After arguing the matter for some time, the learned counsel for the appellant pleaded that the appellant may be permitted to join in the place where he was deputed, ie., Government Arts College for Women, Kumbakonam, with liberty to agitate all the contentions raised by the appellant before the writ Court in W.P.No.13429 of 2017.

4.Recording the above submission made by the learned counsel for the appellant, without expressing any opinion on the contentions raised by the appellant in this writ appeal, the appellant is permitted to join the Government Arts College for Women, Kumbakonam, the place where he was deputed, on or before 01.11.2017. The appellant is also permitted to put forth all his contentions before the writ Court in W.P.No.13429 of 2017.

5.With the above observation, the writ appeal is disposed of. Consequently, the connected miscellaneous petition is closed. No costs.

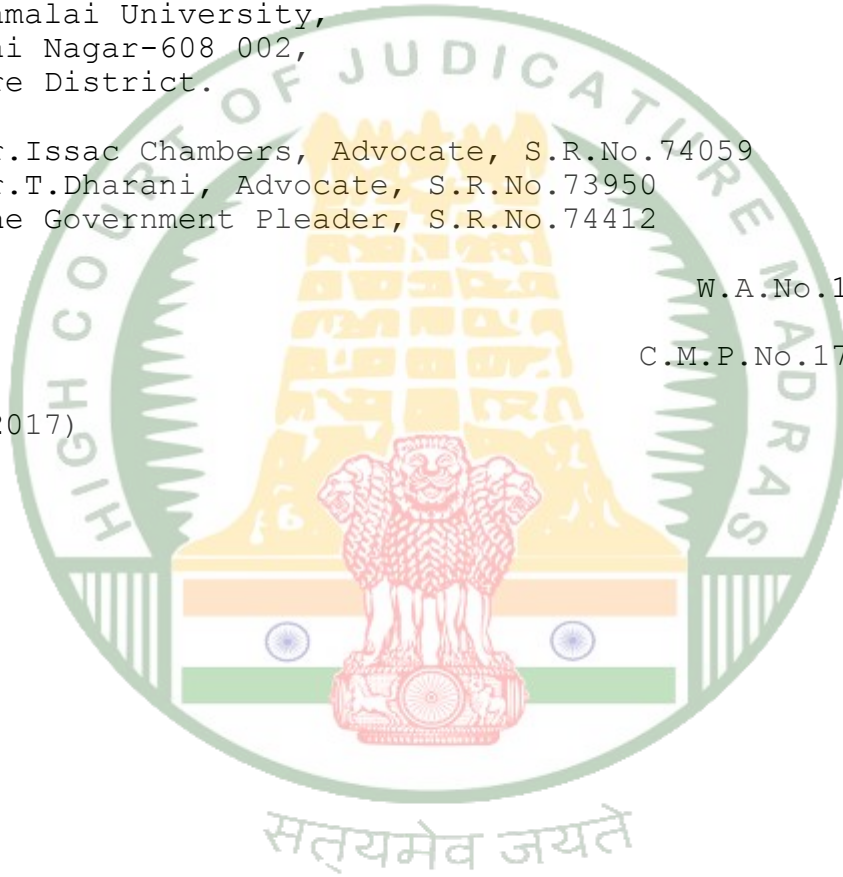
