COMMON JUDGMENT

(Judgment of the court was made by HULUVADI G.RAMESH, J.)

Heard the learned counsel appearing for the appellant.

2. There is a delay of 984 days in re-presenting the writ  
appeal. Apart from that what is seen on merit is that there is

said to be misappropriation of Rs.36/- by the workman, being a conductor. Furthermore, what is noted by the learned Single Judge is that there is said to be irregularity in the matter of enquiry. In such circumstances, we are of the view that there is no scope for either condoning the delay in re-presenting the writ appeal or to entertain the writ appeal. Accordingly, the petition seeking to condone the delay is dismissed and consequently, the writ appeal at SR stage is rejected. No costs.
