This Court, considering the limited relief, without going to the merits of the matter, hereby directs the second respondent-Commissioner, Corporation of Chennai to consider the representation of the petitioner dated 30.11.2016 and pass appropriate orders within a period of four weeks from the date of receipt of a copy of this order.
