The petitioners, who apprehend arrest for the offences punishable under Sections 147, 148, 341, 294(b), 323, 324 and 506(ii) of IPC r/w 3(1)(r), 3(1)(3), 3(2)(v) and 3(1)(1) of the Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015, and SC/ST (Prevention of Atrocities) Act, 1989, in Crime No.115 of 2017 on the file of the respondent Police, have filed this petition seeking a direction to the learned Principal Sessions Judge (Special Judge for SC/ST Act) at Chengalpet, Kancheepuram District, to consider their bail applications on the same day on merits.

2.Mr.C.Emalias, learned Additional Public Prosecutor, takes notice for the respondent.
