Writ Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of certiorarified mandamus calling for the entire records, relating to the impugned order passed by the 2nd respondent in his proceedings in Na.Ka.No.F(2) 2169/2016, dated 28.07.2016 and quash the same and consequently direct the 2nd respondent to issue patta to the petitioner insofar as it relates to T.S.No.245/1, in Door No.145, Kuthoos Gurusamy Salai, Cuddalore Mudhunagar, Cuddalore.

ORDER

The petitioner has come up with this Writ Petition seeking to quash the impugned order dated 28.07.2016 passed by the 2nd respondent vide proceedings in Na.Ka.No.F(2) 2169/2016 and for a consequential direction to the 2nd respondent to issue patta to him in respect of the property at Door No.145, Kuthoos Gurusamy Salai, Cuddalore Mudhunagar, Cuddalore situated in T.S.No.245/1.

2. On a perusal of the records, it is seen that challenging the impugned order dated 28.07.2016, the petitioner has submitted an appeal to the 1st respondent/District Collector, Cuddalore on 22.10.2016 by Registered Post (RPAD).

3. In view of the same, this Court directs the 1st respondent/District Collector, Cuddalore to treat the petitioner's application dated 22.10.2016 as an appeal against the impugned order, and dispose of the same in accordance with law, within a period of four months from the date of receipt of a copy of this order.

The Writ Petition is disposed of with the above direction. No costs. Consequently, connected W.M.P.Nos.1014 and 1015 of 2017 are closed.
