2. 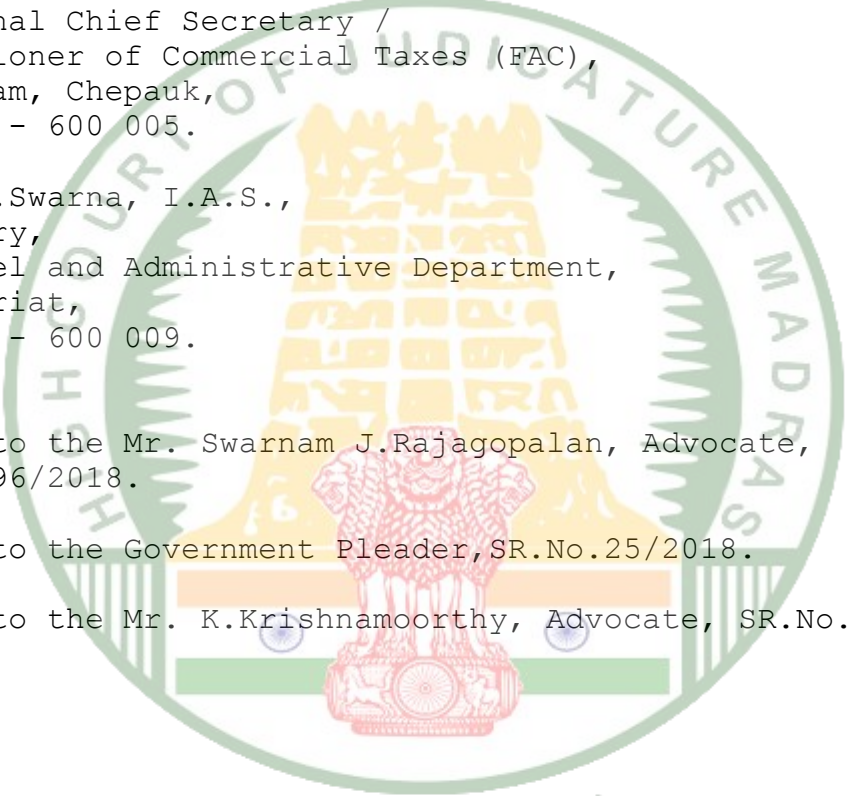
