ORDER

Seeking to quash a portion of the Auction Notice dated 24.03.2017 published in one of the issue of Indian Express, Chennai edition for auctioning the various plots mentioned in the auction Notice dated 24.03.2017 to be held on 29.04.2017 and bringing the Petitioner's Plot 153-C, situated in S.No.523 (part) and 534 (part) more fully described in Schedule for sale, the petitioner is before this Court with this writ petition.

2.It is submitted by the learned counsel for the first respondent Bank that the auction sale in respect of the property in question has not taken place and hence, according to him, nothing survives in this writ petition.

3.In such circumstances, the learned counsel for the petitioner prays for withdrawal of this writ petition. He has also made an endorsement to that effect.

4.In the result, the writ petition is dismissed as withdrawn. However, it is made clear that in the event, the first respondent Bank decides to bring the property of the petitioner for auction sale, it shall issue notice to the petitioner and the petitioner shall furnish his detailed address for service of notice. No costs. Consequently, connected Miscellaneous Petitions are closed.
