The contempt petition is, thus, closed. Consequently, Sub.A.No.282 of 2017 also stands closed.

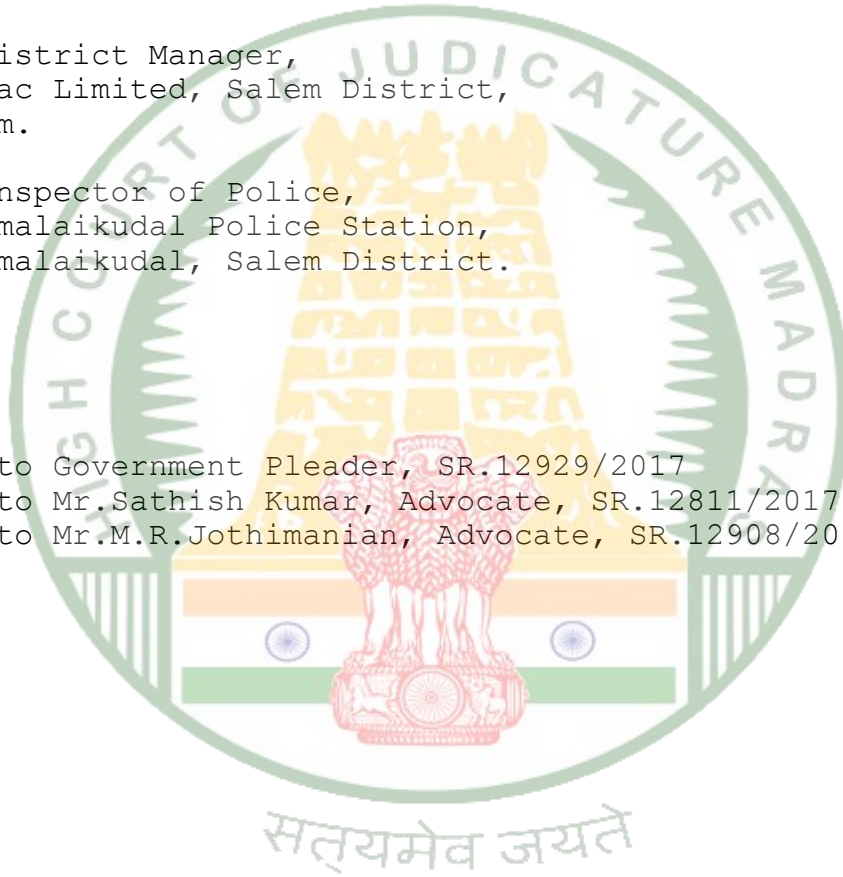
