O R D E R

The relief sought for in this writ petition is for a direction to the respondents 1 and 2 to pass orders on the representation submitted on 07.10.2013, seeking to grant salary from the month of February, 2013.

2.The learned counsel appearing for the writ petitioner made a submission that the salary due to the writ petitioner has not been paid from the month of February, 2013 onwards. In this regard, the petitioner has made a representation to respondents 1 and 2 on 07.10.2013 and the same is yet to be considered.

Thus, without going into the merits of the case, the respondents 1 and 2 are directed to consider the representation submitted by the writ petitioner on 07.10.2013 and pass orders on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order. The petitioner is directed to enclose a copy of the representation along with the order passed in this writ petition.

4. Accordingly, the writ petition stands disposed of. However, there shall be no order as to costs.
