ORDER

After some arguments, the learned counsel for the petitioner on instructions, seeks the permission of this Court to withdraw these writ petitions with a liberty to invoke

Section 10A of the Tamil Nadu Land Encroachment Act, 1905, by filing a revision before the Commissioner of Land Administration, Chepauk, Chennai 600 005 and also made an endorsement to that effect.

2 In the light of the endorsement made, the petitioner is at liberty to file revision before the Commissioner of Land Administration, Chepauk, Chennai 600 005 within a period of two weeks from the date of receipt of copy of this order and if the papers are otherwise in order, the Commissioner of Land Administration shall entertain the same without raising the issue of limitation and thereafter, consider and dispose of the revision as expeditiously as possible in accordance with law.

3 Accordingly, these writ petitions are dismissed as withdrawn subject to the above observations. No costs. Consequently, the connected miscellaneous petitions are also dismissed.
