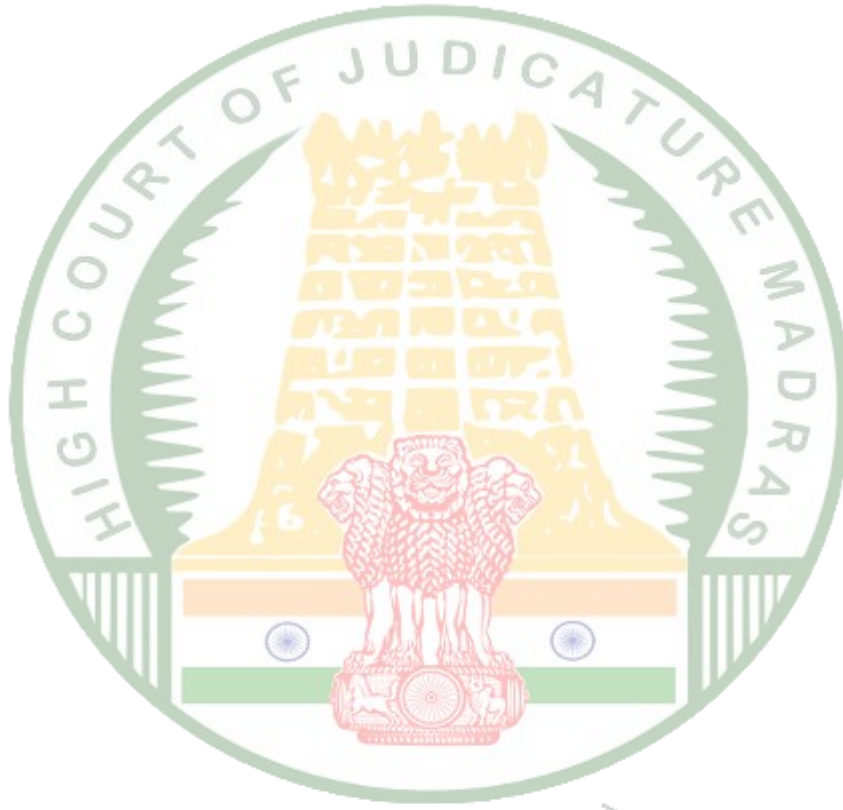

1.1. By virtue of this petition, the petitioner seeks to transfer the detainee, namely, G.E.Chakkarai @ Chakaravarthy, S/o.Elumalai, who is a life convict prisoner, Convict No.436, from Central Prison, Cuddalore to Central Prison, Salem.

2. The learned Additional Public Prosecutor, has produced a proceeding of the Additional Director General of Prison, Egmore, Chennai. The said proceeding is indicative of the fact that the Government has accepted the plea of the petitioner to transfer the detainee, namely, G.E.Chakkarai @ Chakaravarthy, S/o.Elumalai, who is a life convict prisoner, Convict No.436, from Central Prison, Cuddalore to Central Prison, Salem.

2.1. Copy of the said proceeding of the Additional Director General of Prison, Egmore, Chennai is placed on record.

2.2. To be noted, this is a temporary transfer for a period of one (1) year.

3. Having regard to the aforesaid development, the counsel for the petitioner says that, for the moment, the grievance stands satisfied and therefore, he has instruction not to press the petition any further.
