The writ appeal is directed against the order dated 7 March, 2011 in W.P.No.2064 of 2008.

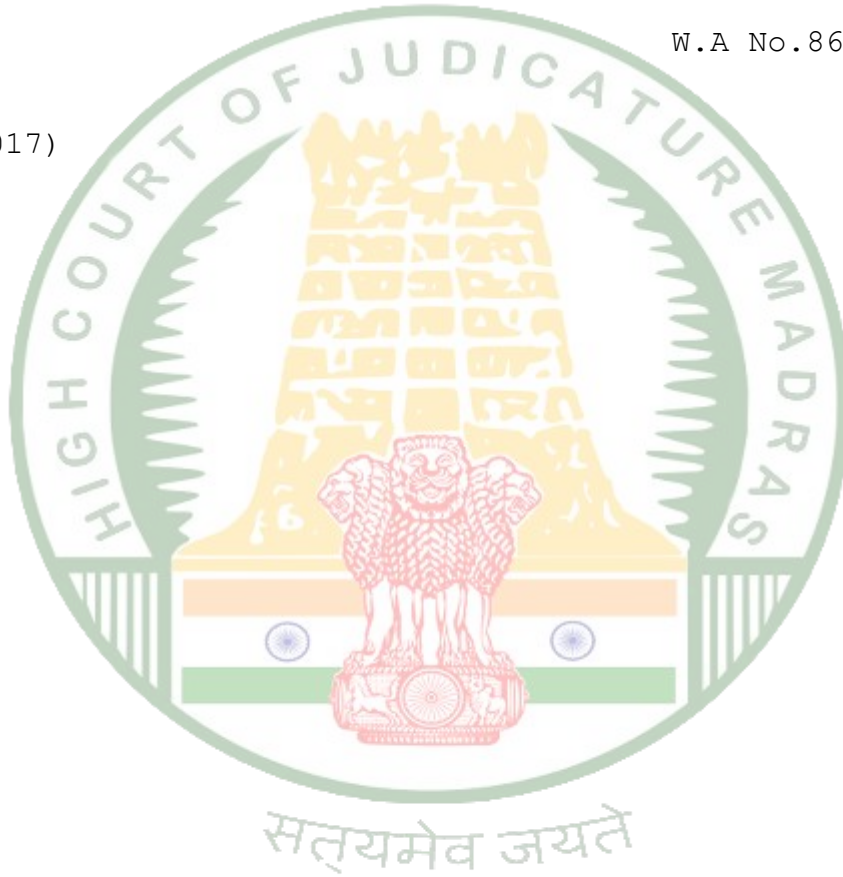
