ORDER

This Criminal Original Petition has been filed seeking for a direction to the respondents to provide police protection to the petitioner and his family and to take action in CSR.No.98 of 2016 dated 01.04.2016.

In view of the limited prayer sought for, there shall be a direction to the fourth respondent to consider the petitioner's representation dated 01.04.2016 and pass appropriate orders in accordance with law, within a period of six weeks from the date of receipt of a copy of this order. While passing final orders, the fourth respondent shall give due opportunity to the persons, who have any claim over the subject property.

4. With the above direction, this Criminal Original Petition stands disposed of.

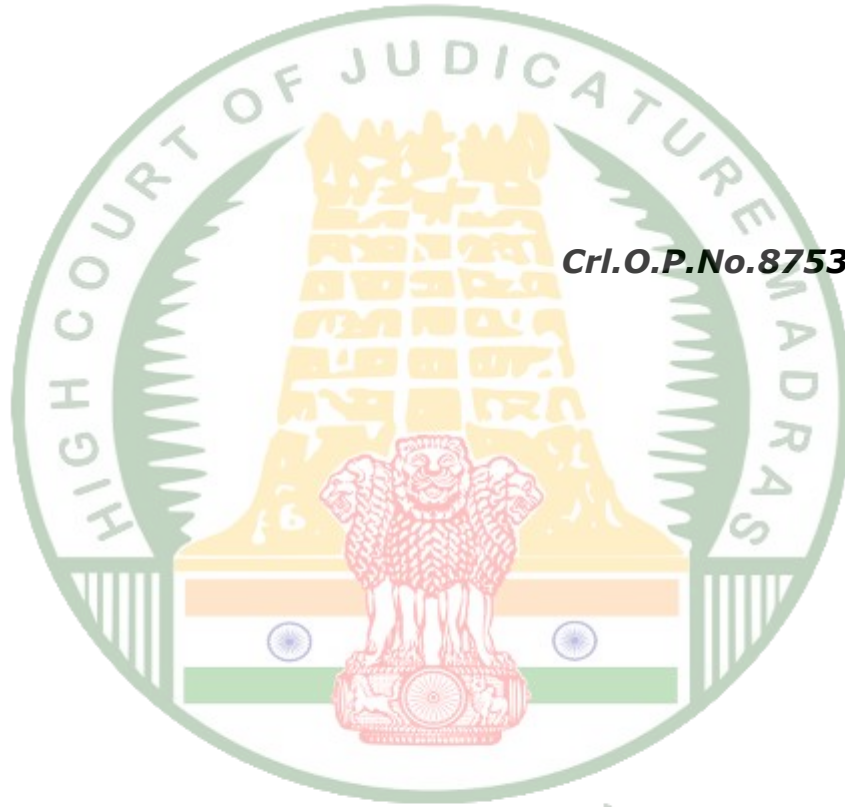
