Learned counsel appearing for the 4th respondent submitted that already no objection certificate has been issued by the District Revenue Officer to the 4th respondent to establish such outlet through proceedings dated 27.03.2017. Therefore, he submitted that the petitioner is not entitled to maintain the present writ petition.

4. Learned counsel for the petitioner seeks liberty to challenge the said order dated 27.03.2017 issued by the District Revenue Officer.

5. Granting such liberty, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
